## About the WLA

The World Lottery Association (WLA) is the professional association of the worldwide government-controlled lottery and sports-betting sector. It supports global standards for lottery management, security and social responsibility, and provides educational and other services to gaming operators and suppliers. The WLA seeks to improve the public's understanding of responsible gaming issues and the role of lotteries in securing funds for good causes. It works with the regional lottery associations to represent the collective interests of its members and foster constructive relationships with worldwide sports federations and other international organizations.

The WLA represents more than 150 government-controlled lottery and sports-betting operators from over 75 countries with combined sales in excess of 280 billion USD. More than 70 gaming suppliers are associate members of the Association.

## Collaborating Membership: Collaborating Member Eligibility

To be eligible for Collaborating Membership, the organization must either be:

a) owned by a jurisdiction in a country recognized by the United Nations that is not identified as having strategic deficiencies by the Financial Action Task Force on Money Laundering, and be a shareholder of a WLA member.

or

b) licensed or authorized, by an above mentioned jurisdiction, to offer the Lottery Games of a WLA member in that jurisdiction provided that the organization has the approval of the WLA member in question. For greater clarity, this provision does not apply to retailers or retailer associations.

Collaborating members do not have voting rights but can, where applicable, participate in WLA certification programs and activities.

Collaborating members' business practices must be compatible with the aims and objectives of the Association. Each application for Collaborating Membership must be endorsed by the WLA member in question and approved by the WLA Executive Committee.

## Membership fees

The annual fees payable by Collaborating Member of the Association are paid in Swiss Francs and are equal to the lowest fee applicable to Associate Members. Currently the fees are fixed at CHF 7000.

Membership fees are payable in Swiss Francs (CHF). Payments made in other currencies will be subject to additional charges in the form of currency exchange fees.

If a WLA Member terminates its membership with the required six month's notice, "WLA By-laws Article VI, paragraph 6.7", it remains liable for all dues and obligations up to the date that the termination becomes effective.
