October 17 – Demystifying and assessing vulnerable groups



Topic: Harm Minimisation Strategy – Supporting Vulnerable / Priority Groups

Title: Neighborhood And Environmental Predictors Of At-Risk And Problem Gambling In Massachusetts.

Kendra Pugh, PhD: Health Science Specialist for the Mental Illness Research, Education & Clinical Center (MIRECC) and Associate Director of VOICES Research at VA Bedford Healthcare System in Bedford, MA

This webinar presents the results of an investigation of the relationship between lottery gambling and the zip code where gambling occurs, as well as the influence of individual-level characteristics that predict at-risk or problem gambling (AR/PG). A GIS analysis was conducted to identify vulnerable areas based on neighborhood characteristics, lottery sales, and AR/PG in Massachusetts. An index of community characteristics that increased risk for AR/PG was created to demonstrate improved targeting of resources and interventions.



Title: Veterans, Gambling Addiction, and Lottery Play: Understanding a Unique and Vulnerable Population

Joshua Grubbs, Ph.D., is an Associate Professor at the University of New Mexico and an investigator at the Center on alcohol, substance use, and addictions, where he studies compulsive sexual behavior disorder, gambling disorder, and personality traits. He is especially interested in the social construction of addiction and understanding what leads people to feel out of control in their behavior. Dr. Grubbs is interested in veteran health and the experiences of U.S. Armed Forces veterans dealing with compulsive, excessive, or out-of-control behaviors. Anne Pattberg is a long-time sustainability professional with broad experience and a record of successful cooperation with the lottery industry. From 2006 to 2011 she headed the sustainability department at Camelot Group plc, reporting directly to CEO Dianne Thompson. During that time, she was also Chair of the European Lotteries Working Group on Responsible Gaming, and was instrumental in the development of both the WLA Responsible Gaming Framework and the EL Responsible Gaming Standard. After Camelot, Anne worked for a number of years in a senior position at PwC, Germany, where she has advised DAX 30 and SME's on sustainability issues as well as conducting a variety of assurance projects, also for many German lotteries. She began her own business in 2015 – PB Consulting GmbH – and continues to work with some of Germany's largest companies in the areas of sustainability strategy, supply chain management, non-financial reporting etc. alongside her work as one of the WLA RG IAP Chairs.
